This is how bail bonds work in the Los Angeles city Jail system, and in Van Nuys California. As soon as you get arrested you will be taken to your local **city jail** in Los Angeles County. You will be allowed one free phone call so make it a good one. Make sure you call a close family member and let them know you are in trouble, and you need to hire a local bail bonds company close to the *city jail*. You must first understand the bail bonds process for Los Angeles City Jail inmates before you get a bail bonds company involved. The Los Angeles County Police Department LASD.org has jurisdiction on 10 local city jails in Los Angeles County, California. Van Nuys Jail, Burbank City Jail, Pasadena City Jail, Glendale City Jail, Hollywood City Jail, West Hollywood Sheriffs, Downtown Los Angeles City Jail. Your local city jail can only house inmates for 72 hours, not counting weekends and holidays.

Bail Agent Requirements for accurate bail data

When you contact a **bail agent**, make sure you have as much information as possible. You need the full first name, last name and middle name of the person, which jail is holding them, their booking number and the charges they are being accused of. Our bail agents are on call 24 hours a day, and will always answer your call regardless of the time of day, whether it is a holiday or not. If the jail is open a *bail agent* is available and can provide full inmate search free of charge.

Once the defendant is released from the jail. They must show up for all court dates and follow any conditions set by the bail agent such as calling and checking in once a week etc. If the defendant fails to appear in court the bail bonds company will be required to pay the full

bond amount. For instance, if your bond is \$5,000 then your bail bonds company will have to pay the full \$5,000 to the court. Or they can hire a private detective and have you captured and surrendered back to the court. Keep in mind that the person who cosigned for the defendant is required to pay back the \$5,000 to the bonding company. That is the agreement the cosigner makes when they decide they are going to help a loved one get out of jail. If the defendant goes to court on time each time then the cosigner does not have anything to worry about, regardless of whether the defendant is guilty or not. The bond will be exonerated and you will no longer be liable.
